Safe Church Overview of Requirements of Pennsylvania and Canon Law The Episcopal Diocese of Bethlehem Updated June 2019

The Commonwealth of Pennsylvania requires all active clergy (including supply), lay employees, vestry members, and volunteers to obtain clearances in order to continue their positions. The law also requires that employees and volunteers be considered mandated reporters of suspected child abuse. All current clergy and employees must be in compliance with these policies, and clearances need to be renewed every 60 months.

In addition to Pennsylvania law, all active clergy (including supply), lay employees, vestry members, volunteers, and key holders, and teenage assistants (14-17 years) in the Diocese of Bethlehem must complete Safeguarding Trainings. These trainings must be renewed every 36 months. Safeguarding Training is done online. Requirements for Clergy and Lay Employees

Diocesan Policies (updated March 2019).

All required modules must be completed on the <u>SafeGuarding website</u>. Please note the required modules changed in 2019. SafeGuarding training must be completed every 36 months.

2) Obtain a Pennsylvania Child Abuse History Clearance.

Keep in mind that as clergy and lay employees, you <u>*cannot*</u> register for clearances and background checks as a volunteer. You are considered an employee.

3) Obtain a Pennsylvania State Police Criminal Record Check.

This can be done through the <u>online portal</u> or you can submit a <u>paper form</u> to:

Keep in mind that as clergy and lay employees, you <u>*cannot*</u> register for clearances and background checks as a volunteer.

4) Obtain an FBI Criminal Background Check.

Go to the <u>IdentoGO website</u> and enter the service code **1KG756**. You will then be able to schedule an appointment at a fingerprinting site near you, and learn what you'll need to bring in order to facilitate processing.

5) Keep documents on file in appropriate location

Clergy
