2026 Church Employee Compensation

(for the legacy Diocese of Bethlehem)

The following resolution was adopted by the 154th Diocesan convention:

Resolved for the calendar year 2026, each geographic area corresponding to the former Diocese of Central Pennsylvania and the former Diocese of Bethlehem shall continue to use its existing compensation policies with an increase of 2.4%.

Be it resolved that the Cash Stipend Range for 2026 be as follows,

| Parish Index | Cash Stipend Range |
|--------------|----------------------|
| 1-99 | \$43,666 - \$52,453 |
| 100-250 | \$48,356 - \$71,504 |
| 251 – 399 | \$57,869 - \$89,083 |
| 400 – above | \$78,096 - \$126,449 |

Be it further resolved that the 2025 Parish Index calculation shall be used in 2026 for purposes regarding Clergy Compensation Cash Stipend calculation.

Be it further resolved that this convention recommends consideration be made for providing an 2.4% cost of living increase for lay employees and recommends consideration be made for additional merit increases for lay employees as performance and resources allow.

Be it further resolved that the Clergy Supply Schedule for 2026 be as follows:

| Service | Rate |
|---|----------|
| 1 Service (Saturday or Sunday) | \$175.00 |
| 2 Services (Saturday or Sunday) | \$215.00 |
| 3 Services (Saturday or Sunday) | \$235.00 |
| 1 Major Service (Holy Week, Christmas, Funeral) | \$175.00 |
| Midweek Service | \$115.00 |

Be it further resolved that a Clergy Compensation Committee will be formed to develop a resolution on church employee compensation for the Diocese of the Susquehanna at its diocesan convention in 2026.

Budget of The Episcopal Diocese of the Susquehanna

The following resolution was adopted by the 154th Diocesan convention:

Resolved, that in 2026, the Assessment Rate applied to the average of Line A, Normal Operating Income (NOI) of the 2021 to 2024 Parochial Reports shall be 10% of the first \$200,000 of this average and then 12% of any excess of \$200,000, limited to no more than 10% of an increase in Assessment from 2025 or no more than 10% of a decrease in Assessment from 2025; and

Be it further resolved that the proposed Diocesan Budget as it is presented to the Convention be adopted.

Agreement and Plan of Merger

WHEREAS, the Diocese of Bethlehem and the Diocese of Central Pennsylvania meeting in their duly called Diocesan Conventions on October 19, 2024, in accordance with Canon I.10.6 of the Constitution and Canons of The Episcopal Church, approved a Joint Agreement of Union to reunify as The Episcopal Diocese of the Susquehanna; and

WHEREAS, the Legal Process Working Group, submits to this Convention the Agreement and Plan of Merger, a legal document outlining a process such that the two dioceses will legally merge, and the name of the merged entity shall be The Episcopal Diocese of the Susquehanna.

Now therefore be it

RESOLVED

That this Convention approves the proposed Agreement and Plan of Merger such that the Diocese of Central Pennsylvania and the Diocese of Bethlehem legally become The Episcopal Diocese of the Susquehanna; and

Directs that said document be submitted to the Attorney General's Office of the Commonwealth of Pennsylvania and such appropriate Orphan's Court of this Commonwealth as may be necessary and proper to legally accomplish the Reunification.

Transitional Canons, Constitution, and Canons of The Episcopal Diocese of the Susquehanna

WHEREAS, The Episcopal Diocese of Bethlehem and the Episcopal Diocese of Central Pennsylvania meeting in duly called Diocesan Conventions on October 19, 2024, in accordance with Canon I.10.6 of the Constitution and Canons of The Episcopal Church, approved a Joint Agreement of Union to reunify as The Episcopal Diocese of the Susquehanna; and

WHEREAS, the Working Group on Constitution and Canons, tasked by the Transition Leadership Committee, submits to this Joint Convention the Transitional Canons, Constitution, and Canons of the Diocese of the Susquehanna whose provisions were included in the Agreement of Union.

RESOLVED That this Joint Convention adopt the proposed Transitional Canons, Constitution, and Canons of The Episcopal Diocese of the Susquehanna.

The Convention voted to adopt the Transitional Canons, Constitution, and Canons of The Episcopal Diocese of the Susquehanna, drafted by the Transition Working Group on Constitution and Canons and updated to reflect feedback gained during listening sessions that took place over the summer. Four (4) pre-filed Amendments were presented and passed on the Constitution and the Canons.
